

**Taylor Borough
Special Meeting Minutes
January 27, 2025**

The Taylor Borough Council held a special meeting on Monday, January 27, 2025, at 7:00 P.M. at the Taylor Municipal Building, 122 Union Street, Taylor, Pennsylvania.

President Mickavicz chaired the meeting.

President Mickavicz opened the meeting with the Pledge of Allegiance.

President Mickavicz asked if anyone from the public had any comment or input on any agenda item, seeing none, Madame Secretary, let the minutes reflect that there was no public input.

Item A to consider a motion to adopt Ordinance #2 of 2025 amending the Civil Service Ordinance, by hereby adopting amended section 2.1 Civil Service Commission regulations to provide for alternate members. Councilman DeAngelo, Yes; President Mickavicz, Yes. After receiving a unanimous vote, Mr. Vincent Rogers is hereby an alternate on the Taylor Civil Service Commission.

Item C is a motion to adopt Resolution #1 of 2025. Be it Resolved that the Borough of Taylor is hereby authorized to enter into a Cooperation Agreement with the County of Lackawanna for the Taylor Borough ADA Curb Ramp Project. The Chair will make a motion to adopt Resolution #1 of 2025. Councilman DeAngelo made a motion and seconded by Councilman Digwood.

Item D is a motion to approve a payment of \$25,000.00 to Taylor Fire and Rescue as per Alliance Landfill Host Municipality Agreement. As stated, the funds were received and rather not wait for the next regular meeting, the Chair will make a motion to approve Item D. Councilman DeAngelo made a motion and Councilman McKeel seconded the motion.
